The Moulton City Council met on Monday, January 5, 2026, with the meeting being called to order at 6:00 PM by Mayor Jason Ogden. The Pledge of Allegiance was recited. Roll call: Terry Pangburn and Mary Boyd present in person. Jewel Thompson and Tyler Thompson were present via conference call. John Replogle was absent. Motion by Pangburn seconded by Boyd to approve the agenda. Roll call: J Thomspson – yes, M Boyd – yes, T Pangburn – yes, T Thompson – yes. Motion passed.

City Supt Report – Nothing to report.

Sheriff's Report – December 2025 – 1 abandoned vehicle/property; 6 ambulance requests; 1 child abuse sexual; 1 civil matter; 5 civil papers served; 2 criminal mischief; 1 disturbance; 1 residential fire; 1 lost/missing person; 1 repossessed motor vehicle; 1 sex offense; 1 theft; 1 traffic stop. 22 total calls and 27.8 hours patrolled.
